- Logs of sent emails.

HOW DO WE COLLECT YOUR DATA?

HOW WILL WE USE YOUR DATA?

YALTA GUESTHOUSE collects your data so that we can deliver emails with attachments to an email address provided by you or contact you or send your data to our payments partner PayPal to process your transaction.

HOW DO WE STORE YOUR DATA?

Our Company securely stores your data on servers in the Netherlands, Israel and the USA. All your data is firewall protected.

WHAT ARE YOUR DATA PROTECTION RIGHTS?

The right to access - you have the right to request YALTA

GUESTHOUSE for copies of your personal data. We may charge you some fee for this.

The right of rectification - you have the right to request Our Company to correct the information you believe is inaccurate.

You also have the right to request YALTA GUESTHOUSE to complete information you believe is incomplete.

The right to erasure - You have the right to request YALTA GUESTHOUSE to erase your data, under certain conditions.

The right to restrict processing - You have the right to request that YALTA GUESTHOUSE restrict the processing of your personal data, under current conditions.

The right to object to processing - You have the right to object YALTA GUESTHOUSE's processing of your personal data, under certain conditions.

The right to data portability - You have the right to request that Our Company YALTA GUESTHOUSE transfer the data to another organization, or directly to you, under certain

conditions.
